1. SCOPE: This data protection statement applies to the processing, by RMD, of personal data relating to its business partners such as customers, health care professionals, suppliers, service providers or agents.

2. PURPOSE OF DATA PROCESSING: In the context of its relation with its business partners, RMD may collect limited personal data such as name and contact details for the purposes of carrying out its business obligations, maintaining the relationship or commercial communications.

6. DISCLOSURE: RMD may share the personal data with third parties in the context of the abovementioned purposes. Personal data is only used by RMD, if it is legitimate, which may imply that your consent is required in advance.

7. STATEMENTS UPDATES: This statement will be, if necessary, updated in the course of time without further notice. It is therefore advisable to visit periodically this page for possible updates.

8. RETENTION: RMD keeps personal data of its business partners for the term of the relationship and where required for an additional term of 10 years. Offers sent to you or received from you remain in our system, unless you object to this and/or indicate in writing that you do not want this.
